



## Regulations 2010

**FILMCARAVAN Imperia travelling short film festival** is an event promoted by the non-profit organization named:

**Associazione Culturale FILMCARAVAN**

The festival is financed by public boards and private sponsors.

### DATES AND LENGTH OF THE FESTIVAL

The second edition of **FILMCARAVAN** will take place in different locations of the province of Imperia and will last four days, from the 4th to the 7th of August 2010.

### ELIGIBILITY

The first edition of the festival counts only one section, the **SHORT FILMS COMPETITION**. Fictions and experimental films of any nationality are eligible, the only restrictions are:

- a duration of less than 35 minutes,
- a date of completion later than the 1<sup>st</sup> of January 2007

Please note that, although mockumentaries and docufictions may be considered, documentary films are not eligible.

### JURY AND PRIZES

The Jury of **FILMCARAVAN** composed of actors, directors, producers, critics, artists and experts in the movie field will contribute to awarding the **GOLDEN CARAVAN 2010** which consist of a trophy and a cash prize of 1000 euros and the **SILVER CARAVAN 2010** consisting in a trophy and cash prize of 500 euros.

### SUBMISSIONS

Submitting to **FILMCARAVAN** is FREE and can be accomplished by completing all parts of the following application form and sending it by mail before the 30th of May, with the following material attached:

- a DVD of the short film (or a multimedia FILE) with English subtitles
- a DVD of the short film (or a multimedia FILE) without subtitles
- the film synopsis
- the director's BIO-FILMOGRAPHY

The DVDs of the films will not be returned and will become part of the Festival archives.*

### SELECTIONS AND FILM PROJECTIONS

The selection will be made by the Board of Organizers and published three weeks prior the beginning of the festival. The Board will also edit a general catalogue of the selected works. The films will be projected from a multimedia file.
